

**Toledo Express Airport/Toledo Walleye  
Around the World Race and Suitcase Crawl Contest  
OFFICIAL CONTEST RULES**

1. Description of the Contest: The Toledo-Lucas County Port Authority (the “Port Authority”) is giving away two (2) international, roundtrip airline tickets on American Airlines to either Cancun, Mexico; London, England; or Tokyo, Japan (Approximate Retail Value \$2600) during the 2016/2017 Toledo Walleye hockey season. The contest will take place during the following games: Saturday, October 22; Wednesday, November 23; Tuesday, December 27; Sunday, January 8; Sunday, January 29; Wednesday, February 1; Sunday, February 12; Sunday, February 26; Sunday, March 5; Wednesday, March 15; Sunday, March 19; Sunday, April 2; and Saturday, April 8. Contestants will be randomly chosen by the Toledo Walleye Staff. Two contestants will start in their hamster balls at the goal closest to the scoreboard end. Once given the go-ahead, both contestants will then begin running around the edge of the rink, around the goal on the opposite side, and then come back to where they started. Along the way, we will have Pond Patrol members stationed as countries from around the world which will allow our PA announcer to better describe the race (i.e. “and here are the racers as they pass Mexico...”). The winner from each race will be brought back as a semifinalist for the end of the year contest on April 8, 2017, where they will compete in the Suitcase Crawl contest. These contestants will be placed on the ice and told to grab one of the briefcases distributed around the rink. Walleye staff will place the same number of suitcases as there are contestants. One of these briefcases will contain a certificate indicating the grand prize. Contestants will not know which piece of luggage contains the grand prize. Contestants will then be blindfolded until they find any piece of luggage they can find. Whichever contestant obtains the luggage containing the certificate will be determined to be the grand prize winner. There can only be one winner of the grand prize.
2. All contestants must be 21 or older to win, and must cooperate with the Port Authority based on the rules defined above. The grand prize winner will be the contestant with the luggage containing the grand prize winning certificate, based on the rules outlined for the game. Prize is non-transferable. No substitution or transfer of prize is permitted. Air travel voucher is for air travel only. Air travel voucher does not include checked bags, assigned seats, hotel, car rental or insurance. All expenses and incidentals not mentioned above, as well as required travel documents, are the responsibility of the winner and winner’s travel guest. Employees of the Toledo-Lucas County Port Authority, American Airlines, Toledo Walleye, and their immediate family members are ineligible to participate in this Contest.
3. All participants must agree to these Official Contest Rules in order to enter this Contest. Entering this Contest constitutes agreement to the Official Contest Rules. Failure to comply with these Official Contest Rules may result in disqualification from the Contest. By entering the Contest, participants agree to comply with and be bound by the Contest results, which are final and binding in all respects.
4. By participating in the Contest, the winner authorizes the Port Authority to use of the winner’s name and/or likeness and/or voice/photograph for promotion and/or advertising purposes in any manner and any medium, including without limitation, radio broadcasts, newspapers, television, videotape, distribution over the internet and picture data storage which the Port Authority may deem appropriate without compensation. The winner must also agree to participate in any media or promotional activity regarding the Contest without compensation.
5. This Contest is governed by the laws of the State of Ohio and is subject to all federal, state, and local laws.
6. The Contest submissions will become the property of the Toledo-Lucas County Port Authority upon receipt and will not be returned after the Contest.
7. **Grand Prize:** One winner will receive
  - a. Two roundtrip, economy-class airline tickets on American Airlines – originating from Toledo Express Airport (TOL) to Cancun, Mexico; London, England; or Tokyo, Japan (Approximate Retail Value \$2600),
8. The winner is to choose three dates between the date of the contest and December 31, 2017 to fly with a companion. The winner is to choose one of the following destinations—Cancun, London, or Tokyo. Preferred dates must be sent to Toledo-Lucas County Port Authority representative, Holly Kemler, by July 31, 2017. The dates will be booked by the Port Authority staff based on availability. The winner may be required to sign legal documentation before the prize can be released. The Port Authority retains the right in its sole discretion to make substitutions of equivalent kind or approximate value in the event of the unavailability of any prize or component of the prize for any reason. The winner will be responsible for the payment of any taxes that apply to the prize as well as any incidentals or expenses. The winner will be issued a tax form 1099 for the total value of the prize. There is no cash alternative and the prizes must be taken as offered. Furthermore, the Port Authority is not responsible for cancellations or delays in travel accommodations and has no obligation to reimburse, refund or otherwise substitute any tickets awarded as a part of a travel prize due to such cancellations or delays.

9. The winner shall schedule a day and time to pick up their tickets from the Port Authority downtown office located on the 7<sup>th</sup> floor of One Maritime Plaza, Toledo, OH.
10. The Port Authority reserves the right at its sole discretion to cancel, terminate, modify, or suspend the contest for any reason in its discretion.
11. By participating in this Contest, the participant fully releases and discharges the Port Authority, the Toledo Walleye, and American Airlines, and their respective directors, officers, and employees from and against any and all actions, charges, claims, losses, costs, damages, expenses (including attorneys' fees and expenses) and liabilities of any kind or character, whether known or unknown, in connection with, arising out of or in any way related to his/her participation in the Contest, including, but not limited to any delays or cancellations in air travel.
